Anyway, the retreat was a great opportunity for us to begin the review process on our guidelines and to update our web site. We were able to have meaningful and in-depth conversations about needed improvements and ideas.

### Looking ahead

A couple of years ago, at our annual meeting in Louisville, Ky., our organization voted on a proposal to condense the size of our Executive Board by reorganizing the makeup of membership on the Board. The intent of this proposal was to improve communications with the membership and to better prepare people to work on committees or to be an officer.

This proposal just missed passing by two votes. Because the vote was so close, it was decided this past November at the annual meeting that a committee would be formed to look into how we might change and improve the proposal.

Nancy Sullivan agreed to chair this task force committee, which was charged with reporting its recommendations on what changes to make, if any, by our spring retreat. This committee spent a great deal of time and energy researching the solution concerning regional directorships.

Currently, the Executive Board membership consists of our four officers, the president of each state Auxiliary (about 13 people), the wife of the current president of the American Angus Association, chairpersons of all our national committees (about 12 people), and all the past presidents of the Auxiliary (about 30 people). Any state that does not have an organized Auxiliary may also send a delegate to represent that

state on the Executive Board (could be about 38 people).

The grand total of Executive Board members could now include about 97 people. Granted, several of these individuals can be counted in more than one category; we have several chairpersons who are also past presidents or we have state presidents who are currently chairing a committee. At this time, the Executive Board meets only once a year in Louisville in November, right before the annual meeting of the membership.

At our retreat, Nancy reported her committee's findings. Their recommendation was to pursue the proposal of realigning the composition of the Executive Board. In order to proceed with this proposal, if that's what our membership wants, we will need to amend our bylaws. We can vote on bylaw changes only at our annual meeting in November.

However, we will address this topic at our midyear meeting at the National Junior Angus Show (Njas) in Tulsa, Okla. We need your input! This is your organization, and as officers we serve at your pleasure. Please e-mail any of us, and plan on attending the midyear meeting.
