Annual Meeting Minutes

President Cortney Hill-Dukehart Cates called the meeting to order. She welcomed everyone and thanked them for attending and introduced special guests. After introductions from the officers, regional directors and executive committee, she recognized American Angus Association and *Angus Journal* staff members, committee chairs, state presidents, Distinguished Women and past Auxiliary presidents in attendance.

Minutes

Attending members of the meeting were given a copy of the 2012 Annual Meeting minutes in their information packets. Rachel Frost moved to dispense with the reading of the minutes and accept them as presented; Melanie Kiani seconded the motion. The motion carried.

Treasurer’s report

For the Treasurer’s report, Lynne Hinrichsen deferred to Leslie Mindemann, bookkeeper. Leslie discussed the profit-and-loss sheet, as well as the balance sheet on a line-by-line basis. She explained there was a payment for travel by Miss American Angus that was paid in October. This is outside the fiscal year and was not included in the final report. Mary Greiman moved to accept the report and Melanie Kiani seconded it. The motion carried.

Regional Director reports

Hill-Dukehart Cates called upon the regional directors to give a brief report of their regions. Full details can be found in their written reports.

Region 1: Kathy Dubs said the Montana Auxiliary continues to do well and has several fundraisers to support the juniors in their state. She also reported on the Western States Auxiliary and their efforts in supporting their juniors.

Region 2: Cindy Ahearn explained that she has spoken to several women in Colorado and Oklahoma about forming a state auxiliary. Currently they are content with working with their state associations to support the breed and the juniors. She has not had any response from her contacts in New Mexico. Texas remains very active with a strong Auxiliary presence.

Region 3: Shally Rogen reported she has four very active Auxiliaries in her six-state region. Currently, Nebraska is showing interest in restarting their Auxiliary and North Dakota is working with their state breed association. She highlighted the fundraising efforts in Iowa, Kansas and Minnesota and said all states are intent on increasing their membership.

Region 4: Martha Holshouser is transitioning off the board as her term is expiring. She recapped that Georgia started their Auxiliary during her term as a director, and Mississippi had an increase in its membership after the regional show in Louisiana. She thanked everyone for allowing her to serve the last five years and said she has met many new friends.

Region 5: Leslie Mindemann reported her states have long-established Auxiliaries, so it allows her to focus on communicating deadlines and new information from the national Auxiliary. She also told the group that she appreciated the opportunity to serve as a director during the past five years. She also has met many new people and made new friends through her work in the Auxiliary.

Region 6: Marlene Dukehart reported she has been working with a few states about starting new auxiliaries. She hit a few highlights from the Atlantic National Auxiliary and show. More details can be read in her annual report. She said she is looking forward to the meeting being moved to Kansas City in 2014.

presidents in attendance for reports. These, as well as other reports, were included in the meeting packets.

Programs and Hospitality — Michelle Rieff invited everyone to the annual Auxiliary breakfast on Sunday.

Certificates of Achievement — Carol Bloom reported that she had more than 64 applications sent to her, and her co-chair, Erica Styles, had more than 120 applicants. She appreciated that this year some states gathered the applications in one packet and sent them to her. She is going to send out a letter to the states with a sample of how to fill out the application.

State reports

Western States — Carla Malson reported how the Western States Auxiliary meets during the Western National Angus Futurity in Reno. They sponsor a Continental breakfast for the exhibitors, scholarships, the showmanship contest awards and have a ways-and-means fundraiser during the show. She regrets reporting that they are losing membership due to people having less time for outside activities.

Montana — Sara Stevenson explained the state continues to sponsor a buckle and jacket award to the top juniors showing cattle throughout the state. They also award two scholarships to the top boy and girl applicants. The Auxiliary continues a membership drive online, supplies food to the juniors during the state show and has a silent auction during its annual banquet hosted during the Northern International Livestock Exposition (NILE) in Billings.

Wisconsin — Mary Kohls told the group that she is working to get her Auxiliary members more involved. A lot of their juniors are younger, and it has been a challenge to get the women involved. They continue with a scholarship program for high-school seniors.

North Carolina — Emily Tennant reported it has been a great year with their Auxiliary. They have had several cake sales as fundraisers, and enlisted the help of Christy Perdue in coming up with a T-shirt that transcends all breeds. In addition, they moved

their scholarship deadline to December so they could announce the recipients at the annual meeting in January. They also will be hosting a regional show next year.

Mississippi — Melanie Kiani told the group she had sent the Certificate of Achievement application to the extension agents in her state to help recruit more applicants. She also includes a line on their preview show entry form that the show qualifies for the certificate. She frames each of the certificates before she presents them to the juniors to make it more special.

Pennsylvania — Nancy Frey talked about their queen's contest. They have a duck derby at the county fair as a fundraiser and auction items at the breeders' show.

Michigan — Nancy Thelen stated that she tracks the accomplishments of her juniors so they know what they can put on their Certificate of Achievement applications.

Idaho — Carla Malson shared that she and one other volunteer manage the duties in Idaho that would normally fall to an Auxiliary. They give an award to the top breeding and Angus-based market animal in every county in their state. They also oversee the queen's contest.

Iowa — Renee Driscoll said she and her Auxiliary provide hospitality to the breeders during their state show in February and support the juniors at the summer shows, including junior nationals. They also help with scholarships for the juniors.

Thank you and recognition

Hill-Dukehart Cates next thanked all the outgoing directors for their hard work and presented gift certificates to them. She then recognized the outstanding work of the committee chairs and presented them with a gift bag.

The candidates for Miss American Angus were introduced. Reigning Miss American Angus, Esther McCabe, thanked the Auxiliary for its support during the past year.
