Spring Executive Committee Meeting – Friday, March 15, 2019 Certified Angus Beef – Wooster, Ohio

Attendance: Cindy Ahearn, Gina Hope, Pam Velisek, Vivian Wolf, Valerie Trowbridge and Marya Haverkamp. Joined via conference call, Leslie Mindemann, Julie Conover and Nancy Thelen and Deanna Hofing (later as the meeting was in progress.)

President Cindy Ahearn called the meeting to order at 3:59 p.m. and lead us in an opening prayer.

Cindy went over general agenda as we waited for Nancy Thelen to call in.

Finance Committee: Nancy Thelen, Chairman, joined us via phone to go over the Finance Committee Report at 4:00 p.m.

CD's: She reported that we have two CD's that come due, one in July and the other in August. Leslie Mindemann would research the rates and our choices and report back to us. Cindy asked if we could make a decision on the one that comes due in July this weekend as we will not meet again prior to July. The amount that comes due on July 9th is \$5,250, this amount would need to be rolled into 2020 and the amount that comes due in August would roll to 2022. Vivian Wolfe asked if we want to split the amounts into something smaller. Leslie and Nancy confirmed that we get better interest rates on the higher amounts so we should leave as is. **Motion:** Vivian made a motion to allow Leslie to renew both CD's at the time of renewal to grab the best deal possible. Gina seconded the motion, **motion passed**.

Julie Conover joined via phone at about 4:30 p.m.

Nancy continued with her report. The Finance Committee will continue with Balance Sheets; to report income and expenses against the activity or project that it pertains to, this allows for truer numbers. Because of this you may see some changes in verbiage, columns and headings. This will make it easier for the membership to follow the profit/loss of each activity.

Scholarship: Nancy went on to suggest that we increase the total scholarships given to total \$18,000 this year. The committee wanted to show that we were increasing the amounts but we use conservative approach. We will use the 3 year average to determine an amount that the committee is comfortable with.

Discussion: Cindy questioned Leslie on the \$50 contribution in the Scholarship Fund and the Educational Awards? Leslie noted that they were a donation from Elouise Hadley's family for her memorial.

Cindy also asked about the \$1,500 Pat Grote Endowment Fund and still not sure how that was allocated. Gina Hope asked if there was a time frame that the funds need to be used by. If they are not used within that time frame they are forfeited. It would make sense that if they were not used they would still show up in fund. Leslie will look into this.

Cindy asked Leslie if she could go over profit/loss next.

Profit and Loss: Leslie stated that last year we split the Ways & Means into three different groups; Other, Featured Fundraiser (Full Circle) and Angus Gift Barn. Income for Other (Gifts that Sizzle) \$960.94, this amount does not reflect Holiday sales. Leslie will follow up with Mary Greiman to get those amounts, if any. The Full Circle Online Auction had a total income of \$9310, of which has all been collected at this point. The Angus Gift Barn had profit at the end of February of \$4,105.26.

Leslie stated that she will charge the expenses of Full Circle against the profit next year to show the true profit. Cindy confirmed that we will get a Full Page ad in the October Journal for Full Circle and it would be FREE! Shally is still considering what other advertising they will do for this coming year's auction. Was discussed that perhaps we could do a flyer that could be put in the exhibitor bags at NJAS and/or a card to be placed on the table at Auxiliary breakfast. Perhaps the committee could do a booth at convention to advertise?

Angus Gift Barn: there was a profit of \$4,105 but we have a lot of old inventory. Gina has concern about the old inventory, total is \$9,612 and we needed to find a way to move it. Cindy stated that not all of that amount is outdated inventory. Leslie said that the profit form NJAS last year was \$4,219.65, if Melanie wanted to add \$4000 of new merchandise you could expect \$100% profit for Junior National. Julie Conover asked if we get the awards for Cook-Off and if we could combine any of the ordering to help with expenses? Caitlyn and Jaclyn order the awards for Cook-Off. Vivian Wolfe suggested that we order a limited number of items, when it's gone, it's gone! Gina asked if we could get rid of some of the old inventory on Craig's List. No real discussion on this followed. Julie suggested that if she found a bigger item that we try to pre-sell some on Face Book and have people pick up at NJAS. Marya Haverkamp suggested that we put some ideas out on Face Book and see what the interest is before we actually purchase items. Cindy thinks that we should all start looking for items that might be poplar and get the suggestions back to Cindy to pass on to Melanie. Vivian asked if we needed to vote on spending \$4000 on merchandise.

Motion: Mayra made a motion to have Cindy, as over-seer of the Gift barn, authorize Melanie to spend the \$4000, Vivian 2nd motion, and **motion carried.**

Discussion: on the Gift Barn, Cindy had spoken to Allen Moczygemba (AAA) that the Auxiliary expenses at the convention are too high and we may not have a presence in Reno in November. There was a lot of discussion about having a smaller booth and just taking a "trunk show" and we fly Melanie out to promote online sales. Julie Conover suggested that we just have the AGB at our meeting and Vivian suggested that perhaps the Auxiliary members could man the booth. Cindy asked Vivian and Valerie to price out shipping cost on perhaps sending the trailer out via freight and Melanie would not need to rent truck this way. Cindy asked Leslie what our target amount for sales would be at convention for AGB, Leslie confirmed \$5000.00. After much discussion it was decided that it was not feasible to take AGB to Reno.

Motion: Cindy asked for a motion; Gina moved that the AGB would not have a presence in Reno due to the fact that it would not be financially beneficial. Pam Velisek 2nd motion, **motion carried.** Cindy will discuss this with Melanie and get her started on purchasing for NJAS in Louisville.

Scholarship Committee: Gina Hope, Chairman. Gina stated that all information has gone out to State Chairpersons, via email.

Motion: Vivian Wolf made a motion that we increase the total scholarships given to \$18,000 based on the recommendation of the Finance Committee. 2nd by Pam Velisek, **motion carried.** Gina acknowledged how well the Scholarship Workshop was attended last year at nationals and asked that we do that again. She would like to use the Executive Committee and perhaps a past winner (either girl or boy) to help put it on. The workshop would be same time as last year, prior to Mid-Year Meeting.

Membership Committee: Jamie Ruthledge sent her report showing that the current total of members is 949. There was a question on who actually gets a free one year member for one year, current Scholarship winner or Miss American Angus, or both? Cindy tabled question and stated that it required more research. Leslie stated that MAA candidates get a one year membership and once MAA is crowned she receives a Life Membership. This is something that needs to be clarified in the Guidelines. It would be a maximum of 5 girls. Cindy stated that Jamie asked about the hard copy of Auxiliary Post be a question on the membership form. To increase membership, the person bringing the most new members to Mid-Year meeting receives a \$100 to AGB.

Nominating Committee: Chairperson Leslie Mindemann said that her committee held initial conference all to begin the process of seeking nominees for Regional Directors and Secretary/Treasurer. She stated that she needed to look at by-laws regarding regions 4 and 6 as both of those positions have been appointed. We need to check and see if they want to run again. Valerie Trowbridge stated that she did want to run (she is filling Reg. 6). Leslie asked if anyone had suggestions for Regional 5, which will be up for election and also Secretary/Treasurer position. There was discussion about the by-laws and the fact that if you are an officer of the Auxiliary your child cannot run for a scholarship. This has been cause for a great deal of discussion over the last year and whether or not we need to consider a by-laws change. (Deanna Hofing joined in via phone) Julie Conover stated that lowa had discussed it a great deal. The question had been posed to Bylaw Committee Chair Pam Bailey if this was "legal" and she stated that it is an ethics decision rather than a legal decision. It is the "appearance" of impropriety that can be damaging as an actual conflict of interest. Both Cindy and Valerie commented on the fact that it appears we have no faith in our judges and it is

insulting to their integrity to be objective. Vivian suggested we could do a survey using a "survey monkey" and see how the membership feels about. Cindy took an informal poll of all present and on phone and the general consensus is the only position that really would be affected is the President Elect as they serve as Scholarship Chair. Cindy will look further into survey.

We adjourned for Cocktails and Dinner at 6:55 p.m. We had a lovely evening making a "featured" cocktail and Steak Rubs with Chef Ashley.

Saturday, March 16, 2019

Toured the CAB Headquarters with Deanna Walenciak, Director of Education at 8:30 a.m.

Continued Executive Committee Meeting from Friday

Deanna Hofing joined via phone.

President Cindy Ahearn called meeting to order at 9:48 a.m.

Because we never actually approved the Executive Committee Minutes on Friday, Cindy entertained a motion to approve minutes from Executive Committee Meeting from 4/20/2018. **Motion:** Deanna moved to accept minutes as presented and Pam 2nd motion. **Motion carried.**

Program and Hospitality: We discussed the Mid-Year meeting that will be held in Louisville during NJAS in July. Co-Chairs Jeana Hurlbut and Lindsay Sankey are consulting with Anne Patton Schubert and Mrs. Boyd about Kentucky Derby traditions and doing something fun with Hats and maybe Mint Juleps. We will have our fundraiser of the "Chinese Auction" and it will continue to be called Chinese Auction because that is what known and recognized by most people. Pam will send reminders to Regional Directors to bring two items for auction. Regional Directors to set up. Pam will also bring tickets, bags and everything for auction. Pam and Gina will run check-in and may need some help.

We also discussed the Annual Meeting at this time. Question was asked who controls Auxiliary Breakfast. All food goes thru Certified Angus Beef. Food was awful this past year! Last year the ticket price was \$35 and the actual cost per person was \$36. Cindy suggests that we cap at 300 people. How many tickets were comped last year, Cindy will try to get exact number from Jaclyn Upperman, Dir. of Activities AAA. Cindy would like to talk to Jaclyn and Caitlyn about taking over the breakfast and we (auxiliary) would just buy tickets thru association and pay for the tickets that we comp (MAA judges, contestants). Texas will be responsible for table decorations this year and it is not known if flowers will be available from the Foundation dinner as we are not sure what the Foundation will be doing this year. Texas will have a gift for each attendee and it will be small and most likely consumable. State Presidents and Executive Committee to bring door prizes, Cindy will check with Shally on how names are drawn from the "door prize list"? We all agreed that the Annual Meeting time needed to be separate from the Executive Committee Meeting. This past year Leslie had in early morning in her hotel suite and it worked well. It was discussed as to whether or not we needed food at the Annual Meeting and it felt that really we should just have drinks available at the Executive Board Meeting and Annual Meetings.

(Julie and Leslie joined via phone at this time, as far as we know as there was no tone indicating when they joined)

Cook Off: Anne Patton Schubert has asked that all Regional Directors and Officers be available to assist with the cook off if they are not previously committed. Cook Off will be July 16, 2019 at 1:00 p.m. Anne contacted Cindy and Gina prior to the meeting to voice her unhappiness with the Journal for not printing the full committee. It has been stated that only Anne and Anne will be listed as Committee Chairs and the full committee will not be printed. Cindy stated that our contact with Angus Media for Cook Off is Leanne Schliecher. Angus Media will print the Cook Off recipe booklet and there will be no charge for this.

(Leslie asked that we move forward to Public Relations committee and Foundation information as she would need to leave the conference call soon. – Executive Board Meeting)

Public Relations: Cindy gave a brief history on what happened last year right before the Mid-Year meeting regarding Angus Journal costs to the Auxiliary. Leslie was presented with a power point of what the AJ gives to the Auxiliary which totaled \$33,000 that was gratuitous. This set everyone in a tailspin as we were led to believe that the auxiliary would now be charged for these services in the future. Rick Cozzitorto was hired to restructure Angus Media and get them back in the black. The Association has been funding the Angus Journal for some time and they have stated that will not continue in future. Julie Murnin was asked to prepare a proposal (as directed by an Executive Committee vote done at the 2018 NJAS in Madison emergency called meeting) and it was presented to Rick Cozzitorto on December 7th via a conference call with Julie, Cindy and Rick. We are not being charged for Auxiliary Notes because this is an editorial. Rick accepted our full proposal and we even got a full page ad for the Full Circle Auction that will be free! In order to save money for the Auxiliary and Angus Media, Julie Murnin will comp her services and will make everything "camera ready" for the Journal. Rick C. left Angus Media the first week of January as his assignment was complete. We have done what was agreed to with Rick, however since his departure there seems to be confusion going on at Angus Media. Julie is not getting format tools needed to format as agreed and Julie has done everything camera ready and the Angus Media changes it. Cindy has gone to Allen Moczygemba (interim President of Angus Media) and let him know the agreement is not being

honored. Cindy will get back to us on why the agreement is not being followed once she has more answers. At the time of printing all issues have been resolved.

Regarding Website, we are also not able to update the Website. Rick had said to save on cost we would be able to go in and make our own updates (we being Julie Murnin). We were told that this is too difficult and apparently Rick misspoke when he told Julie and Cindy this could be done. Cindy has met with Andy Blumer (Web Services Team Lead at Angus Media) and he has said they will update our page once a month based on what Julie sends them. This will be without charge as long as no design time is needed. For the record; in 2016 there was 35 hours of design time, 2017 we got billed for 27 hours and in 2018 there was 18 hours.

Cindy has a paper trail of all conversations and emails with Rick C., she is sending all to Allen M. for review and he has promised he will honor what was told to the Auxiliary prior to Rick's departure. Cindy repeated that Rick was NOT FIRED, he was brought in as a "fixer" and that is what he did. Allen understands the history of the Auxiliary with Angus Media and will report back to Cindy once he has researched it all.

Leslie questioned the maintenance fee for the Website of \$350 and yes we are still responsible for that fee that is a normal charge for websites. She also asked if we could get something in the form of a contract so we don't have to go through this every year. We should revisit this prior to budget next year, around August or September.

Leslie asked if the association had been contacted regarding funds they donate to Auxiliary (\$13,500) and Pam will send letter.

Leslie asked about the constant contact and are we using it? Cindy stated yes, Communication with Chelsea Duis could improve however. Leslie sent her an email to see if her email address had been dropped because she has not seen anything and never got a response to that either. Our subscription is up to 1000 addresses; Cindy will reach out to her by phone and see if all is okay. Cindy also will reach out to Anne Lampe to post more on Facebook about Angus Gift Barn because that has also dropped off. (At the time of printing, this has been reviewed and resolved by Cindy and Julie Murnin).

Foundation: Cindy reported what she had learned regarding the Foundation. As with Angus Media, the Foundation was also losing money and the association was donating funds to keep it afloat. The AAA Board had asked for an outside auditor to come in and determine why it is not self-sustaining. Milford Jenkins, President of Foundation, was aware of the request from the board and understood why the audit was needed. The long and short of it was there was too much money going into administrative cost and not enough into investments. There have been many rumors and "fake news" regarding Milford's departure and Cindy wanted to share what she learned. The police were called to AAA Headquarters on the day that Milford was asked to go home and consider his options but it was because NJAA Chairman Sdyney Gerkin's wallet had been stolen out of her car and they were there to investigate. Gossip spread and it was not

factual. Milford came back the following Monday with his decision and chose to resign. He acknowledged that the Foundation needed new blood and left on good terms. Moving forward, the Foundation is looking to restructure. They will look for a Director of Development and a Director of Marketing, those two positions will report to Allen Moczygembo. The Foundation Board is in total support, they know it needs to be fixed so the association is not pouring money into the Foundation. Allen said they would reduce the number of scholarships but not the dollar amount of total scholarships. Again Allen assured Cindy that Milford left on good terms.

Leslie inquired if our management fee would be going up and it most likely will. Julie Conover felt sure the operating expenses for endowments would increase but most likely will not change for a year. It was noted because our endowment is closed and managed by the AAA Foundation Board cannot change it. It was discussed that Anne Patton Schubert may have a copy of the Auxiliary's Endowment paperwork when it was set up. It needs to be checked. Cindy said she had received many calls regarding the Auxiliary's funds and she is assured it will remain safe!

Full Circle Auction: Chairman Shally Rogen is evaluating items to auctioned. She is looking for State Presidents and Regional Directors to secure donations that value between \$100-\$500 and also work to "sell" these items. The Committee wants to approve all items. The auction date this year is November 7, 2019 and you can look for a lot of marketing at the convention. Because we do not have to pay for a Full Page ad this year, perhaps we could do a flyer for the registration package.

(Leslie signed off of conference call about 11:17 a.m.)

Miss American Angus: Gina Hope, Scholarship Chair will communicate with the candidates (after selected at NJAS) regarding the room reservations. The auxiliary will reimburse for one room, per candidate, for two nights of competition. The candidate will be responsible to send in receipt for reimbursement from the auxiliary. This will hopefully avoid the confusion that occurred this year and we will not be chasing money after the convention. Whitney Renfro and Mallory Trosper will be stepping down as Co-Chairs and handing over the reins to Paige Arnold and Cortney Cates after this year, 2019 will be a transitional year.

Julie Conover asked who was in charge of the Queen's Lunch this year at NJAS. She was advised that the host state is responsible and we do not know who is handling this for Kentucky for 2019.

Awards: Jaclyn Upperman said that all awards have been ordered. We have two Rattey's for presentation already this year. We will be out of Rattey's after this year, we can re-order from Pamela Harr (Harvey Rattey's widow). We need to find out from Caitlyn Brandt if we are still

doing this award before we re-order. The Auxiliary receives 40% off the cost if six sculptures are ordered at one time. Sculpture is called "Miss Liberty" and is given to the Intermediate A & B Extemporaneous Speaking winners. Julie asked why we are splitting Intermediates between A and B when there is so little participation. Age covered in the division is why, not fair for a 12 year old to compete against a 17 year old.

Events and Education: NJAS, officers and regional directors must get hotel forms back to Caitlyn Brandt ASAP or let her know you are staying at a different hotel. It was suggested that Julie Murnin develop a post card for Auxiliary to promote Full Circle, Scholarships, etc. The Queen's Luncheon will be Monday, July 15th at 9:30 a.m. and it is strongly suggested that all Aux. directors attend.

For the Mid-Year meeting check-in we may do a Google Sheet so all membership documents update simultaneously. It was suggested that two name tags get filled out and one left on table for us to do check-in on computer. Perhaps this will move the line along faster. Also suggested that all who owe dues be highlighted. May a table set up for just updates and changes to contact information. If no changes go to the "express line".

Mentor Program: Cindy reported that there has been little to no interest in this program and we will try it once again this year. If there is no response this year we will discontinue the program. Over \$600 was spent last year to mail the Member flyer to the aging out Seniors. Cindy has requested from Jaclyn an email list for communication to increase the chance of contact and to be more economical with our budget.

Motion: Gina Hope made a motion to adjourn the Executive Committee meeting at 12:34 p.m. Vivian Wolf seconded. **Motion carried.**

It was decided that all other items and committees had been discussed previously in the weekend and no further business to review. Gina Hope made a **motion** to adjourn and Valerie Trowbridge seconded. Meeting was adjourned at 3:26 p.m. **Motion carried.**

Spring Executive Committee Meeting – Friday, March 15, 2019 Certified Angus Beef – Wooster, Ohio

Attendance: Cindy Ahearn, Gina Hope, Pam Velisek, Vivian Wolf, Valerie Trowbridge and Marya Haverkamp. Joined via conference call, Leslie Mindemann, Julie Conover and Nancy Thelen and Deanna Hofing (later as the meeting was in progress.)

President Cindy Ahearn called the meeting to order at 3:59 p.m. and lead us in an opening prayer.

Cindy went over general agenda as we waited for Nancy Thelen to call in.

Finance Committee: Nancy Thelen, Chairman, joined us via phone to go over the Finance Committee Report at 4:00 p.m.

CD's: She reported that we have two CD's that come due, one in July and the other in August. Leslie Mindemann would research the rates and our choices and report back to us. Cindy asked if we could make a decision on the one that comes due in July this weekend as we will not meet again prior to July. The amount that comes due on July 9th is \$5,250, this amount would need to be rolled into 2020 and the amount that comes due in August would roll to 2022. Vivian Wolfe asked if we want to split the amounts into something smaller. Leslie and Nancy confirmed that we get better interest rates on the higher amounts so we should leave as is. **Motion:** Vivian made a motion to allow Leslie to renew both CD's at the time of renewal to grab the best deal possible. Gina seconded the motion, **motion passed**.

Julie Conover joined via phone at about 4:30 p.m.

Nancy continued with her report. The Finance Committee will continue with Balance Sheets; to report income and expenses against the activity or project that it pertains to, this allows for truer numbers. Because of this you may see some changes in verbiage, columns and headings. This will make it easier for the membership to follow the profit/loss of each activity.

Scholarship: Nancy went on to suggest that we increase the total scholarships given to total \$18,000 this year. The committee wanted to show that we were increasing the amounts but we use conservative approach. We will use the 3 year average to determine an amount that the committee is comfortable with.

Discussion: Cindy questioned Leslie on the \$50 contribution in the Scholarship Fund and the Educational Awards? Leslie noted that they were a donation from Elouise Hadley's family for her memorial.

Cindy also asked about the \$1,500 Pat Grote Endowment Fund and still not sure how that was allocated. Gina Hope asked if there was a time frame that the funds need to be used by. If they are not used within that time frame they are forfeited. It would make sense that if they were not used they would still show up in fund. Leslie will look into this.

Cindy asked Leslie if she could go over profit/loss next.

Profit and Loss: Leslie stated that last year we split the Ways & Means into three different groups; Other, Featured Fundraiser (Full Circle) and Angus Gift Barn. Income for Other (Gifts that Sizzle) \$960.94, this amount does not reflect Holiday sales. Leslie will follow up with Mary Greiman to get those amounts, if any. The Full Circle Online Auction had a total income of \$9310, of which has all been collected at this point. The Angus Gift Barn had profit at the end of February of \$4,105.26.

Leslie stated that she will charge the expenses of Full Circle against the profit next year to show the true profit. Cindy confirmed that we will get a Full Page ad in the October Journal for Full Circle and it would be FREE! Shally is still considering what other advertising they will do for this coming year's auction. Was discussed that perhaps we could do a flyer that could be put in the exhibitor bags at NJAS and/or a card to be placed on the table at Auxiliary breakfast. Perhaps the committee could do a booth at convention to advertise?

Angus Gift Barn: there was a profit of \$4,105 but we have a lot of old inventory. Gina has concern about the old inventory, total is \$9,612 and we needed to find a way to move it. Cindy stated that not all of that amount is outdated inventory. Leslie said that the profit form NJAS last year was \$4,219.65, if Melanie wanted to add \$4000 of new merchandise you could expect \$100% profit for Junior National. Julie Conover asked if we get the awards for Cook-Off and if we could combine any of the ordering to help with expenses? Caitlyn and Jaclyn order the awards for Cook-Off. Vivian Wolfe suggested that we order a limited number of items, when it's gone, it's gone! Gina asked if we could get rid of some of the old inventory on Craig's List. No real discussion on this followed. Julie suggested that if she found a bigger item that we try to pre-sell some on Face Book and have people pick up at NJAS. Marya Haverkamp suggested that we put some ideas out on Face Book and see what the interest is before we actually purchase items. Cindy thinks that we should all start looking for items that might be poplar and get the suggestions back to Cindy to pass on to Melanie. Vivian asked if we needed to vote on spending \$4000 on merchandise.

Motion: Mayra made a motion to have Cindy, as over-seer of the Gift barn, authorize Melanie to spend the \$4000, Vivian 2nd motion, and **motion carried.**

Discussion: on the Gift Barn, Cindy had spoken to Allen Moczygemba (AAA) that the Auxiliary expenses at the convention are too high and we may not have a presence in Reno in November. There was a lot of discussion about having a smaller booth and just taking a "trunk show" and we fly Melanie out to promote online sales. Julie Conover suggested that we just have the AGB at our meeting and Vivian suggested that perhaps the Auxiliary members could man the booth. Cindy asked Vivian and Valerie to price out shipping cost on perhaps sending the trailer out via freight and Melanie would not need to rent truck this way. Cindy asked Leslie what our target amount for sales would be at convention for AGB, Leslie confirmed \$5000.00. After much discussion it was decided that it was not feasible to take AGB to Reno.

Motion: Cindy asked for a motion; Gina moved that the AGB would not have a presence in Reno due to the fact that it would not be financially beneficial. Pam Velisek 2nd motion, **motion carried.** Cindy will discuss this with Melanie and get her started on purchasing for NJAS in Louisville.

Scholarship Committee: Gina Hope, Chairman. Gina stated that all information has gone out to State Chairpersons, via email.

Motion: Vivian Wolf made a motion that we increase the total scholarships given to \$18,000 based on the recommendation of the Finance Committee. 2nd by Pam Velisek, **motion carried.** Gina acknowledged how well the Scholarship Workshop was attended last year at nationals and asked that we do that again. She would like to use the Executive Committee and perhaps a past winner (either girl or boy) to help put it on. The workshop would be same time as last year, prior to Mid-Year Meeting.

Membership Committee: Jamie Ruthledge sent her report showing that the current total of members is 949. There was a question on who actually gets a free one year member for one year, current Scholarship winner or Miss American Angus, or both? Cindy tabled question and stated that it required more research. Leslie stated that MAA candidates get a one year membership and once MAA is crowned she receives a Life Membership. This is something that needs to be clarified in the Guidelines. It would be a maximum of 5 girls. Cindy stated that Jamie asked about the hard copy of Auxiliary Post be a question on the membership form. To increase membership, the person bringing the most new members to Mid-Year meeting receives a \$100 to AGB.

Nominating Committee: Chairperson Leslie Mindemann said that her committee held initial conference all to begin the process of seeking nominees for Regional Directors and Secretary/Treasurer. She stated that she needed to look at by-laws regarding regions 4 and 6 as both of those positions have been appointed. We need to check and see if they want to run again. Valerie Trowbridge stated that she did want to run (she is filling Reg. 6). Leslie asked if anyone had suggestions for Regional 5, which will be up for election and also Secretary/Treasurer position. There was discussion about the by-laws and the fact that if you are an officer of the Auxiliary your child cannot run for a scholarship. This has been cause for a great deal of discussion over the last year and whether or not we need to consider a by-laws change. (Deanna Hofing joined in via phone) Julie Conover stated that lowa had discussed it a great deal. The question had been posed to Bylaw Committee Chair Pam Bailey if this was "legal" and she stated that it is an ethics decision rather than a legal decision. It is the "appearance" of impropriety that can be damaging as an actual conflict of interest. Both Cindy and Valerie commented on the fact that it appears we have no faith in our judges and it is

insulting to their integrity to be objective. Vivian suggested we could do a survey using a "survey monkey" and see how the membership feels about. Cindy took an informal poll of all present and on phone and the general consensus is the only position that really would be affected is the President Elect as they serve as Scholarship Chair. Cindy will look further into survey.

We adjourned for Cocktails and Dinner at 6:55 p.m. We had a lovely evening making a "featured" cocktail and Steak Rubs with Chef Ashley.

Saturday, March 16, 2019

Toured the CAB Headquarters with Deanna Walenciak, Director of Education at 8:30 a.m.

Continued Executive Committee Meeting from Friday

Deanna Hofing joined via phone.

President Cindy Ahearn called meeting to order at 9:48 a.m.

Because we never actually approved the Executive Committee Minutes on Friday, Cindy entertained a motion to approve minutes from Executive Committee Meeting from 4/20/2018. **Motion:** Deanna moved to accept minutes as presented and Pam 2nd motion. **Motion carried.**

Program and Hospitality: We discussed the Mid-Year meeting that will be held in Louisville during NJAS in July. Co-Chairs Jeana Hurlbut and Lindsay Sankey are consulting with Anne Patton Schubert and Mrs. Boyd about Kentucky Derby traditions and doing something fun with Hats and maybe Mint Juleps. We will have our fundraiser of the "Chinese Auction" and it will continue to be called Chinese Auction because that is what known and recognized by most people. Pam will send reminders to Regional Directors to bring two items for auction. Regional Directors to set up. Pam will also bring tickets, bags and everything for auction. Pam and Gina will run check-in and may need some help.

We also discussed the Annual Meeting at this time. Question was asked who controls Auxiliary Breakfast. All food goes thru Certified Angus Beef. Food was awful this past year! Last year the ticket price was \$35 and the actual cost per person was \$36. Cindy suggests that we cap at 300 people. How many tickets were comped last year, Cindy will try to get exact number from Jaclyn Upperman, Dir. of Activities AAA. Cindy would like to talk to Jaclyn and Caitlyn about taking over the breakfast and we (auxiliary) would just buy tickets thru association and pay for the tickets that we comp (MAA judges, contestants). Texas will be responsible for table decorations this year and it is not known if flowers will be available from the Foundation dinner as we are not sure what the Foundation will be doing this year. Texas will have a gift for each attendee and it will be small and most likely consumable. State Presidents and Executive Committee to bring door prizes, Cindy will check with Shally on how names are drawn from the "door prize list"? We all agreed that the Annual Meeting time needed to be separate from the Executive Committee Meeting. This past year Leslie had in early morning in her hotel suite and it worked well. It was discussed as to whether or not we needed food at the Annual Meeting and it felt that really we should just have drinks available at the Executive Board Meeting and Annual Meetings.

(Julie and Leslie joined via phone at this time, as far as we know as there was no tone indicating when they joined)

Cook Off: Anne Patton Schubert has asked that all Regional Directors and Officers be available to assist with the cook off if they are not previously committed. Cook Off will be July 16, 2019 at 1:00 p.m. Anne contacted Cindy and Gina prior to the meeting to voice her unhappiness with the Journal for not printing the full committee. It has been stated that only Anne and Anne will be listed as Committee Chairs and the full committee will not be printed. Cindy stated that our contact with Angus Media for Cook Off is Leanne Schliecher. Angus Media will print the Cook Off recipe booklet and there will be no charge for this.

(Leslie asked that we move forward to Public Relations committee and Foundation information as she would need to leave the conference call soon. – Executive Board Meeting)

Public Relations: Cindy gave a brief history on what happened last year right before the Mid-Year meeting regarding Angus Journal costs to the Auxiliary. Leslie was presented with a power point of what the AJ gives to the Auxiliary which totaled \$33,000 that was gratuitous. This set everyone in a tailspin as we were led to believe that the auxiliary would now be charged for these services in the future. Rick Cozzitorto was hired to restructure Angus Media and get them back in the black. The Association has been funding the Angus Journal for some time and they have stated that will not continue in future. Julie Murnin was asked to prepare a proposal (as directed by an Executive Committee vote done at the 2018 NJAS in Madison emergency called meeting) and it was presented to Rick Cozzitorto on December 7th via a conference call with Julie, Cindy and Rick. We are not being charged for Auxiliary Notes because this is an editorial. Rick accepted our full proposal and we even got a full page ad for the Full Circle Auction that will be free! In order to save money for the Auxiliary and Angus Media, Julie Murnin will comp her services and will make everything "camera ready" for the Journal. Rick C. left Angus Media the first week of January as his assignment was complete. We have done what was agreed to with Rick, however since his departure there seems to be confusion going on at Angus Media. Julie is not getting format tools needed to format as agreed and Julie has done everything camera ready and the Angus Media changes it. Cindy has gone to Allen Moczygemba (interim President of Angus Media) and let him know the agreement is not being

honored. Cindy will get back to us on why the agreement is not being followed once she has more answers. At the time of printing all issues have been resolved.

Regarding Website, we are also not able to update the Website. Rick had said to save on cost we would be able to go in and make our own updates (we being Julie Murnin). We were told that this is too difficult and apparently Rick misspoke when he told Julie and Cindy this could be done. Cindy has met with Andy Blumer (Web Services Team Lead at Angus Media) and he has said they will update our page once a month based on what Julie sends them. This will be without charge as long as no design time is needed. For the record; in 2016 there was 35 hours of design time, 2017 we got billed for 27 hours and in 2018 there was 18 hours.

Cindy has a paper trail of all conversations and emails with Rick C., she is sending all to Allen M. for review and he has promised he will honor what was told to the Auxiliary prior to Rick's departure. Cindy repeated that Rick was NOT FIRED, he was brought in as a "fixer" and that is what he did. Allen understands the history of the Auxiliary with Angus Media and will report back to Cindy once he has researched it all.

Leslie questioned the maintenance fee for the Website of \$350 and yes we are still responsible for that fee that is a normal charge for websites. She also asked if we could get something in the form of a contract so we don't have to go through this every year. We should revisit this prior to budget next year, around August or September.

Leslie asked if the association had been contacted regarding funds they donate to Auxiliary (\$13,500) and Pam will send letter.

Leslie asked about the constant contact and are we using it? Cindy stated yes, Communication with Chelsea Duis could improve however. Leslie sent her an email to see if her email address had been dropped because she has not seen anything and never got a response to that either. Our subscription is up to 1000 addresses; Cindy will reach out to her by phone and see if all is okay. Cindy also will reach out to Anne Lampe to post more on Facebook about Angus Gift Barn because that has also dropped off. (At the time of printing, this has been reviewed and resolved by Cindy and Julie Murnin).

Foundation: Cindy reported what she had learned regarding the Foundation. As with Angus Media, the Foundation was also losing money and the association was donating funds to keep it afloat. The AAA Board had asked for an outside auditor to come in and determine why it is not self-sustaining. Milford Jenkins, President of Foundation, was aware of the request from the board and understood why the audit was needed. The long and short of it was there was too much money going into administrative cost and not enough into investments. There have been many rumors and "fake news" regarding Milford's departure and Cindy wanted to share what she learned. The police were called to AAA Headquarters on the day that Milford was asked to go home and consider his options but it was because NJAA Chairman Sdyney Gerkin's wallet had been stolen out of her car and they were there to investigate. Gossip spread and it was not

factual. Milford came back the following Monday with his decision and chose to resign. He acknowledged that the Foundation needed new blood and left on good terms. Moving forward, the Foundation is looking to restructure. They will look for a Director of Development and a Director of Marketing, those two positions will report to Allen Moczygembo. The Foundation Board is in total support, they know it needs to be fixed so the association is not pouring money into the Foundation. Allen said they would reduce the number of scholarships but not the dollar amount of total scholarships. Again Allen assured Cindy that Milford left on good terms.

Leslie inquired if our management fee would be going up and it most likely will. Julie Conover felt sure the operating expenses for endowments would increase but most likely will not change for a year. It was noted because our endowment is closed and managed by the AAA Foundation Board cannot change it. It was discussed that Anne Patton Schubert may have a copy of the Auxiliary's Endowment paperwork when it was set up. It needs to be checked. Cindy said she had received many calls regarding the Auxiliary's funds and she is assured it will remain safe!

Full Circle Auction: Chairman Shally Rogen is evaluating items to auctioned. She is looking for State Presidents and Regional Directors to secure donations that value between \$100-\$500 and also work to "sell" these items. The Committee wants to approve all items. The auction date this year is November 7, 2019 and you can look for a lot of marketing at the convention. Because we do not have to pay for a Full Page ad this year, perhaps we could do a flyer for the registration package.

(Leslie signed off of conference call about 11:17 a.m.)

Miss American Angus: Gina Hope, Scholarship Chair will communicate with the candidates (after selected at NJAS) regarding the room reservations. The auxiliary will reimburse for one room, per candidate, for two nights of competition. The candidate will be responsible to send in receipt for reimbursement from the auxiliary. This will hopefully avoid the confusion that occurred this year and we will not be chasing money after the convention. Whitney Renfro and Mallory Trosper will be stepping down as Co-Chairs and handing over the reins to Paige Arnold and Cortney Cates after this year, 2019 will be a transitional year.

Julie Conover asked who was in charge of the Queen's Lunch this year at NJAS. She was advised that the host state is responsible and we do not know who is handling this for Kentucky for 2019.

Awards: Jaclyn Upperman said that all awards have been ordered. We have two Rattey's for presentation already this year. We will be out of Rattey's after this year, we can re-order from Pamela Harr (Harvey Rattey's widow). We need to find out from Caitlyn Brandt if we are still

doing this award before we re-order. The Auxiliary receives 40% off the cost if six sculptures are ordered at one time. Sculpture is called "Miss Liberty" and is given to the Intermediate A & B Extemporaneous Speaking winners. Julie asked why we are splitting Intermediates between A and B when there is so little participation. Age covered in the division is why, not fair for a 12 year old to compete against a 17 year old.

Events and Education: NJAS, officers and regional directors must get hotel forms back to Caitlyn Brandt ASAP or let her know you are staying at a different hotel. It was suggested that Julie Murnin develop a post card for Auxiliary to promote Full Circle, Scholarships, etc. The Queen's Luncheon will be Monday, July 15th at 9:30 a.m. and it is strongly suggested that all Aux. directors attend.

For the Mid-Year meeting check-in we may do a Google Sheet so all membership documents update simultaneously. It was suggested that two name tags get filled out and one left on table for us to do check-in on computer. Perhaps this will move the line along faster. Also suggested that all who owe dues be highlighted. May a table set up for just updates and changes to contact information. If no changes go to the "express line".

Mentor Program: Cindy reported that there has been little to no interest in this program and we will try it once again this year. If there is no response this year we will discontinue the program. Over \$600 was spent last year to mail the Member flyer to the aging out Seniors. Cindy has requested from Jaclyn an email list for communication to increase the chance of contact and to be more economical with our budget.

Motion: Gina Hope made a motion to adjourn the Executive Committee meeting at 12:34 p.m. Vivian Wolf seconded. **Motion carried.**

1. What is happening with your committee?

Communication has gone out to the state scholarship chairs regarding this year's scholarship application changes, a reminder to go to the website (link was provided in communication) to ensure the state chairs were familiar with the application, requirements and process. Also advised them of the proposed increase of \$1,000 to the total disbursement making it \$18,000 for 2019.

2. How can the Executive Committee or Executive Board assist you with goals for your committee? I do – there has been a good bit of change since last summer within the American Angus Association that has effected the Auxiliary. I believe we need to ensure we communicate to the entire membership to be positive and think of ideas to work with the current AAA administration to benefit the association but more importantly to complete our ideas and mission for the auxiliary. Going to war with the powers that be just brings to mind for me the saying that you get more flies with honey than vinegar. I believe before we lash out we need to do fact finding and have one spokesman speak for us to eliminate negative perception of the Auxiliary.

5. Do you have any ideas to increase membership? Ideas to encourage outgoing NJAA members to join the AAAX?

Would the employee "put them up" for a week and let them shadow?
